John joined The Rehabilitation Network (TRN) as a Case Manager in 2006. He has a background as a Clinical Hypnotherapist, Counsellor and Personal Development Coach with more than 20 years' experience working with individuals and groups to facilitate personal growth and change.

Though his background may be unusual for this type of role, he was recruited as a Case Manager for his assessment and treatment planning skills and his knack for problem solving after providing psychotherapy services as part of TRN's treatment provider panel. During the time since he has gained extensive experience with a wide variety of injuries including multiple orthopaedic, spinal, acquired brain injury and psychological sequelae and has demonstrated a natural ability to thoroughly assess the needs of an injured / disabled person and develop a multidisciplinary approach to rehabilitation, and provide vocational assistance with a return to work where feasible.

His understanding of the Case Management process together with his grasp of working with insurers and solicitors and his ability to forge good working relationships with all key stakeholders led to his appointment as the Quality Assurance Manager for TRN in 2009, where he became responsible for supervising the work of all TRN's Case Managers. He is now the owner of TRN and maintains his own case work as well as managing a team of Case Managers plus a panel of treatment providers.
